Such candidates are hereby directed to submit the hard copies as well as soft copies of these documents (if not submitted) as mentioned against their name(s) in the said list mentioned before Remark/Compliance column. The link to print Online Application form is open for those candidates who have not submitted hard copies of the online application form and hard copies of documents required to decide the merit criteria **(Click here to print Online Application form). These essential documents must reach to the University within working hours, latest by 17/03/2022 upto morning 11:00 a.m.** (email: fccc@muhs.ac.in).

If the candidate fails to submit these (as per in the said list Remark /Compliance column) documents / copies of the application form and / hard copies of documents required to decide the merit criteria within time, then his / her application will not be processed further and it will be decided as per policy decision of the University in this regards.
